The Holy Trinity Romanian American Orthodox Church, as part of the Romanian Orthodox Archdiocese of America, an Episcopate of ROMA Metropolia (effective 11 November 2022), under the provisions of the Metropolia ROMA's Statutes and Parish Manuals, members with the right to vote at the above stated Parish General Assembly Meeting, are only those "parishioners in good standing" of the Church, who have submitted to the parish office, a Parish Membership Application, under Metropilia ROMA, and have met their stewardship obligations to the Parish (Chapter XXXVI - Parish Assembly, Article 36.01 & Article 36.02).

No person shall be deemed a parishioner in good standing while not adhering to the standards outlined in Articles 25.01 and 25.02; and defies the jurisdiction or the ecclesiastical authority of the Archdiocese/Metropolia ROMA (Chapter XXV – Parishioners, Article 25.04).

Membership fee: Employed adults: \$ 250.00/per year/per person. Retirees/Pensioners and Students: \$ 150.00 /per year/per person.
